<b>3.3.1 Error Identification</b>	<b>A</b>	Supported. Automatic feedback screens are generated on knowledge check and lab drill questions. Lab drill quizzes provide results slides with an option to "Retry Quiz" if an acceptable score was not achieved.
<b>3.3.2 Labels or Instructions</b>	<b>A</b>	Supported. Learners are given instructions when they need to interact with module content.

<b>Skip Links</b>	Learners can skip repetitive navigation links by selecting the "skip navigation" option that is easily found using a screen reader.
<b>Open/Closed Captions</b>	Captions are provided for all informational videos, multimedia, and audio. Learners can stop and start all in-slide multimedia pieces using keyboard controls.
<b>Audio Descriptions</b>	Audio descriptions are provided for content.
<b>User-Selectable Audio and Text Descriptions</b>	All audio descriptions can be selected by the user.
